the source for sentencing data and analysis

- As of August 12, 2024, 934 defendants have been sentenced by 26 district court judges in the U.S. District Court for the District of Columbia.¹
- These judges were comprised of 13 District, 10 Senior, 1 Chief, and two magistrate judges.
- Of these, 448 were felony convictions, 486 were misdemeanors.

- Of the felonies, 388 defendants received a sentence of incarceration, and 66 received probation.
- Of those felonies receiving a sentence of incarceration, the average sentence was 14.6 months and the median 1 months.
- Of the felony probationary sentences, 177 received some form of alternative sanctions (e.g. home confinement or halfway house).



- Of the 486 misdemeanors, 139 defendants received a sentence of incarceration, and 356 received probation.
- Of those misdemeanors receiving a sentence of incarceration, the average sentence was .9 months and the median 0 months.
- Of the misdemeanor probationary sentences, 127 received some term of alternative custody (e.g., home confinement or halfway house).

- •A number of sentences, primarily for petty offenses, carried *both* terms of incarceration and probation.
- •The term of incarceration, however, was comprised of intermittent confinement (e.g., weekends in jails).
- •The D.C. Circuit Court of Appeals recently ruled that this method of sentencing is illegal if the sentence of the "intermittent" term of incarceration exceeds 60 days.
- •Following this ruling, the district courts appear to have ceased this practice.
- •In our analysis, many errors were corrected that appeared in the Department of Justice's online report, including erroneous sentence lengths.



The above chart ranks the Jan 6 judges in order of average sentence of incarceration for all felonies by length in months.






Sentencing Distribution Segmented by Select Ranges: Felonies



The above histogram chart displays the count of felony Jan 6 sentences within ranges. The chart reveals the largest segment of 140 sentences ranged from one day (.03) to one year and one day (12.03) and comprise 31% of felony sentences. The second largest segment of 60 sentences ranged from probation to one day (0.03), comprising 13% of felony sentences.



Sentencing Distribution Segmented by Select Ranges: Misdemeanors



The above histogram chart displays the count of Jan 6 sentences within ranges. The chart reveals the largest segment ranged from probation to one day (.03) making up 63% of sentences, and the second largest segment ranged from one day to three months, comprising 31% of sentences.

The average sentence was highest amongst judges appointed by Reagan, followed by Trump. The most lenient sentences were imposed by judges appointed by Biden, followed by George W. Bush.
